Anti-Ragging Policy

Kandaswami Kandar's College, a reputed institution is keen on providing academic ambience to the students. As a part of its vision and in the direction of the University Grand Commission, takes steps to make the institution ragging free campus.

In pursuance of the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the University Grants Commission has framed "UGC Regulations on curbing the menace of ragging in higher educational institutions, 2009" which have been notified on 4th July, 2009 in the Gazette of India.

Kandaswami Kandar's College, Velur shall constitute an Anti-Ragging Committee as per the instructions of the government.

Ragging is defined as: "Any disorderly conduct whether by words spoken or written or by an act which the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or indiscipline activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or any other student or asking the students to do any action perform something which such student will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or any other student."

Objectives of Anti-Ragging Committee

Anti-Ragging Committee will be the supervisory and advisory committee in preserving a Culture of Ragging Free Environment in the Campus. The main objectives of this cell are as follows:

- To aware the students of dehumanizing effect of ragging inherent in its perversity.
- To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
- To promptly and stringently deal with the incidents of ragging brought to its notice.
- To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.

Functions of the Anti-Ragging Committee

- Display the contacts of the committee in the campus.
- Mention anti Ragging Warning in the campus, diary and website.
- To design strategies and action plans for curbing the Menace of Ragging on the campus.
- To plan awareness campaigns about moral and ethical principles, human rights, dignity, and gender parity.
